LIA Register Membership request module

Craft enterprises (legal persons, partnerships and sole proprietorships) that carry out craft works in the fields indicated by the Council of State in the Rules must be registered in the LIA Register (Articles 1 and 2 LIA, Art. 1 RLIA, and Appendix to RLIA).

1. Trade category in which registration in the LIA Register is requested

Registered enterprises are authorized to carry out only craft works comprised in the trade category in which they are registered (Art. 7, paragraph 1, RLIA).

Enterprises which carry out works in more than one trade category and general enterprises which carry out craft works must meet the requirements established for each category and obtain registration in every one of them (Art. 7, paragraph 2, RLIA).

3. Owner or effective senior member (Arts. 4, 6-8 LIA; Art. 5 RLIA)

For the purposes of registration the person who effectively takes part in management of the company, dedicates his work mostly to it and represents it can be considered the owner or effective senior member (*) (Art. 4, paragraph 3, LIA), through signatory power, member of the Business Register (if the company is registered).

(*) For the companies with head office in Italy: a further form of publication of the technical managers in the Registers, which the Italian companies identify in a transparent manner, for the management of their business in Switzerland, and upon whom, for the purposes of membership in LIA Register, verifications are performed for possession of the requirements specified by LIA. The declaration to be made to the EAR (Economic and Administrative Repertory) defines the figure of the "Technical Manager Representative of the company for business performed in Switzerland". After confirmation of the correct company proxies by the competent Italian bodies, this position takes on an external value and recognition to third parties through publication in the EAR and registration in the Chamber of Commerce.

5. Final provisions

False or forged declarations can lead to criminal proceedings according to the Swiss Penal Code.

All modifications of trade or personal requirements, as well as the statute of the enterprise must be notified within one month (Art. 8 RLIA).

Disciplinary and/or criminal proceedings remain reserved in the event of operation of a company not inscribed in the Register, of artisanal activities subject to the LIA (arts. 20 and 22 LIA).

By signing this form, the enterprise/owner authorizes its insurance entity and tax authorities to provide the Supervisory Committee LIA with any complementary information, in the amount necessary for the verification of the enrolment request.

With signature of the module, the company seeks to pay the balance of the enrolment cost of CHF 600 for membership in a trade category (art. 19 LIA, art. 11 paragraph 1, letter a RLIA), CHF 300 for additional trade categories (art. 19 LIA, art. 11, paragraph 2 RLIA), respectively the amount of CHF 200 for examination of the request in case of negative result of the same (art. 19 LIA, art. 11 paragraph 3 RLIA).

6. Attachments

The instructions, which can be downloaded from the site www.albo-lia.ch, specify which attachments are necessary and where they can be obtained. Such documents will not be returned. Once the online form has been completed it should be printed, stamped, dated and signed. This document contains a summary of the personalized list of documents to be enclosed with the application.

New online management

Upon completion of the online Module, the system allows the user to upload the requested attachments, previously scanned, in order to allow their prior examination (submission of paper copies of the documents is also required). Beside each document appears a plus sign "+". The secretary validates the documents and refuses those not in compliance by advising the applicant. Once validated, the user may not modify them further. The secretary is immediately informed of the completed requests, and can proceed to their fulfillment according to priority and chronological order. The requests, individually accompanied by the attached paper copies are processed in chronological order by their entry date.

Procedure for submitting the application for registration in the LIA Register

To apply for registration in the LIA Register the following is recommended:

- Ask the concerned institutes and entities for the documents to be enclosed with your application in the required form.
- Complete the LIA Register online application form on the site www.albo-lia.ch If possible, upload the required attachments online
- Once the form has been completed it should be printed, stamped, dated and signed.
- Attach to the form the whole of the required documentation, summarized per convenience, on the same form (if possible, already uploaded online).
- Send the documentation or deliver it to the office of the Commissione di vigilanza LIA (LIA Supervisory Committee), Via Zorzi 36, CP 1066, 6500 Bellinzona 2 (the use of certified post is recommended). **Please send all the required attachments in one envelope only to speed up the processing of your application.**

For registration in more than one category: complete the form for the first category, after the application form is saved (submitted) data for logging into the system again will be sent to the contact email address. Call up data on the enterprise and apply for an additional category with which to associate the owner or corresponding senior member.
